The Lithium polymer battery with a Watt-hour rating not exceeding 100Wh or the cell with a Watt-hour rating in not exceeding of 20Wh, The Lithium polymer battery according to Section II/Section IB of PACKING INSTRUCTION 965, or Section II of PACKING INSTRUCTION 966 $\sim$ 967 of the Dangerous Goods regulations 61th Edition may be transported.
